One day Jesus was feasting in the house of Levi, a tax collector, when the Pharisees asked him a question about fasting – <u>"John's disciples fast,</u> Pharisees fast, why the Lord's disciples did not fast"? (Luke 5:33-39) Jesus could have given them a direct answer; yes, Jesus and his disciples did fast and pray. They may have fasted even more than everybody else but Jesus chose to challenge the cause rather than the symptom in his asked Jesus them reply. three questions that flushed out the root of their unbelief.

Jesus first asked them, "do they recognize that a bridegroom is in the room?" Do they recognize that he is the bridegroom and a wedding is about to happen? If they recognized him as the bridegroom, they would have listened to him. They would have made him the center of their attention; everybody's eyes would be on him. He would have been the center of every discussion and they would have given him the honor worthy of a bridegroom. While asking them to focus on him first, Jesus also implied that there was a chance that they could miss the real reason for their prayer and fasting. Do we give Jesus the first priority in our life and keep him the center of our attention? Beyond all the hustle and bustle, do we still focus on the real reason behind our religious activities?

Jesus then asked the second question using a parable about new wine poured into old wineskin. In those days, wine was stored in containers made of animal new wine is active, leather. The ferments, and expands; the wineskin must stretch with the wine. Jesus first asked if the Pharisees accepted Jesus as the bridegroom. If they accepted Jesus as the bridegroom, Jesus would not be just a spectator; instead, he asked them if they were willing to stretch. David had a very simple formula for deciding what belonged to God vs. him. Anything leftover, free, and painless to achieve, i.e., costs little or nothing, belonged to him, but if it is expensive, it belonged to God. Are we willing to stretch for Jesus? What costs are we willing to pay to follow him? Finally, Jesus asked them if they could withstand the stretching and avoid spilling the precious wine by bursting the wineskin. Simply put, Jesus asked them if they could hold it together. It is interesting to note that the only criterion to achieve eternal life is if one could cross the finish line.

It doesn't matter how fast one runs, how many people one overtakes, how many overtake us, and how many times one falls. We could run limping, jumping, leaping, and tumbling, but if we can cross the finish line, we will win the prize – eternal life. How are we running our race? What are the hindrances to us crossing the finish line? When troubles come, persecution comes; can we hold it together?

Towards the end of his life, while writing his second letter to his disciple, Timothy, Paul talks about his confidence regarding achieving the crown, i.e., eternal life. He assures himself and Timothy that he has fought a good fight, has the line of sight to cross the finishing line successfully, and has kept the faith. He had many distractions along the way, but Paul was very clear about his priorities forgetting the past while focusing on the future and discarding many things that were profitable along the way. Can we confess that Christ will be the center of the bridegroom, our lives, who deserves all our attention and focus? Can we confess that we will give our best to him, even when it costs us? Can we hold it together just as Paul did? I pray that the Lord will enable us to differentiate and prioritize what is eternal and celebrate together in heaven.

Kings Caravan 2.0





Living Root Bridges

Discovering Resilience and Innovation in Traditional Architecture



The Living Root bridges found throughout the East Khasi Hills of Meghalaya are a testament to the self-sufficiency of the Khasi tribes and their deep connection with the forests. These unique bridges are constructed entirely from tree branches, trunks, and roots, showcasing the ingenuity and resourcefulness of the local people.

> The process of building these bridges begins with carefully placing young, flexible aerial roots from Ficus Elastica trees into hollowed-out trunks of the Areca Catechu tree, a type of palm tree. These trunks not only provide essential nutrients and protection from the elements to the young roots but also act as a guide for their growth. A bamboo framework is used to support the entire structure during the initial stages of construction.

> As the aerial roots grow stronger and thicker over time, the Areca Catechu trunks become unnecessary and are eventually removed. To further strengthen the bridge, a combination of stones, timber planks, leaves, and soil is

added to fill gaps and test the weight-bearing capacity of the living root structure. The humid climate of Meghalaya, along with the regular pedestrian traffic on the bridge, helps to compact the soil and dead load, enhancing the bridge's stability. After 15 to 30 years, the living root structure becomes robust enough to support significant weight without the need for the bamboo framework. Unlike traditional concrete bridges, Living Root bridges actually become stronger and more resilient with age and use, making them a sustainable and eco-friendly alternative for crossing rivers and valleys in the region.

A vocational training program will be organized for youths who have limited opportunities in society, identified from rural villages in Northern India. These youths will receive full scholarships for their training.

Upon successful completion, they will be guided to generate income for themselves and participate in community development projects in their villages.

The Philip John & Tom Philip Education Foundation (PCEF) was established in 1986 by two prominent businessmen from the USA, the late Mr. Philip John & the late Mr. Tom Philip. Their vision was to provide rural youths with the skills needed to generate income for their survival. The institute has successfully trained numerous rural youths and helped them earn a living. Unfortunately, the institute had to close during the COVID-19 pandemic.
